If you are sending multiple applications at the same time and the return address is the same for all applicants, you only need to provide one request form per party.

**TYPED APPLICATION** – Hand written forms are not accepted - The application we supply will allow you to type directly onto the form. Please complete pages 1 and 3 only, leaving page 2 blank.

**ORIGINAL PASSPORT** - with a minimum of 6 months validity & 2 blank pages. Non British/EU passport holders must also supply the UK residence card.

**COPY OF LAST ANGOLAN VISA WHERE APPLICABLE** - If your visa is in a different passport to the one you are now applying on, please also supply a copy of the passport ID page of the passport that the visa is in.

**2 x UK PASSPORT PHOTOS**

**COPY OF LETTER FROM EMPLOYER** – letter confirming your employment position & reason/place of travel on letterhead paper.

**COPY OF PROOF OF ADDRESS** – one of the following documents: water, gas or electricity bill, council tax letter, UK driving license

**COPY OF RETURN FLIGHT ITINERARY** - (return being no later than 10 days). Please note that the flight dates **must** correspond with those mentioned on the invitation.

**COPY OF RECENT BANK STATEMENT** - issued within 45 days of application. Online banking will not be accepted unless it contains the name, address & transactions. You can black out the account number only.

**COPY OF INTERNATIONAL CERTIFICATION OF VACCINATION (Yellow Fever book)**

## INFORMATION FOR THE ANGOLA VISA SERVICE

You can apply no more than 2 weeks before your planned arrival date.

Processing time in the embassy is 2-10 business days depending on your travel date.

For standard processing, we must submit your documents no more than 6-10 business days before you travel.

For express processing, the documents would be submitted within the same week (3 business days) of travel. We must receive your documents at least 4 business days before your requested date of travel.

Business days are Monday to Friday & do not include weekends.

This visa is valid for 72 hours from the date of issue & the maximum stay is 10 business days from the date of arrival.

Extensions must be made in Angola. The embassy will issue the visa on the day of your flight for you to arrive in Angola within the 72 hours. For this reason, we usually deliver the passport to you at Heathrow airport on the day that you travel which will be coordinated with you. Should you require delivery at a different airport, or have your passport returned via a different method, please let us know & we will confirm if this is possible.

This embassy will only process applications for UK nationals or residents.

When your documents have been received, we will check that they are correct before contacting you (via the email address provided) to confirm receipt and provide your invoice. If you prefer to send your cheque or postal order with your documents, you can, however, we request that no payment is made before we can check that everything is in order.

Payments can be made by PayPal, Bank Transfer, cheque or postal order. Please note that we do not begin to process your request until your payment has been made. All fees are per person.

When you receive the email to confirm when your documents have been received, it will contain your unique reference number. For all queries during your process, you must quote this reference number or we will not be able to provide information. This is to protect your security. We will only email with additional instruction or to confirm the return details for your passport which will contain your visa inside. You must check your visa on receipt & advise immediately if there are any queries.

You will only receive email updates if there are any delays.
