**NIGERIA TOURIST VISA APPLICATION PACK**

Please supply this form, fully completed (typed or by hand), with all documents in the checklist below. Failure to provide any of the documents will result in a delay to your application. All forms must be printed and signed.

If you are sending multiple applications at the same time and the return address is the same for all applicants, you only need to provide one request form per party.

**1. CHECKLIST OF DOCUMENTS YOU MUST SEND**

**COPY OF PASSPORT** - The original must have a minimum of 6 months validity.

**APPLICATION QUESTIONNAIRE** - attached. The application is completed online so we provide a manual questionnaire to complete. Once your information has been placed onto the embassy system, we will email the application to you.

**UK PASSPORT PHOTO** - taken no more than 1 Month before submission

**LETTER OF INVITATION FROM NIGERIA** - For those staying with family or friends only. Must be signed and dated, addressed to the Nigerian High Commission London, with the full address. It must include the address where the applicant will be staying in Nigeria. The inviter must state they take full immigration responsibility for the Applicant when in Nigeria. A copy of the inviter passport must be supplied & if a non Nigerian national, a copy of their Nigerian residence permit.

If invited by a Nigerian spouse, you must also supply a copy of your marriage certificate. The original must be taken to your appointment.

**BANK STATEMENT** - A clear copy and original of the applicant's full recent bank statement showing all details including the balances, name & address. The statement must also include transactions during the week of the applicant's appointment in our centre. Online banking statements will only be accepted if they are stamped or certified by your bank. The bank statement must show a minimum balance of £500.00 in credit.

## INFORMATION FOR THE NIGERIA VISA SERVICE

Nigerian visas have a two step process. Firstly, the application must be completed online. At the time of completing the application, an appointment must be made for the applicant to attend the application centre in London to submit the application documents and supply fingerprints. We complete the online application, book your appointment & prepare your documents in order for them to be accepted at your appointment. The application pack will be emailed to you to print & sign ready to take to your appointment.

Please note that the application centre currently does not allow the collection of passports once the visa is ready. For this reason, all applicants must provide a pre-paid special delivery envelope to return the passport at the appointment. This can be purchased from the Post office before you attend or the application centre.

Fees: The visa fees must be paid by card at the centre – this would be done in two payments, £20.00 application centre handling fee & the requested visa fee. Please ensure you carry £10.00 in cash as they will also ask for this to make the payment at the centre. All cards must be in the applicants name which matches the details on the application form.

Processing time in the embassy is usually 1 week for standard service or 2 days for express service but can take longer. Please note that should the express service be used, you will need to take a postal order for £70.00 made payable to the Nigerian High Commission. Once the embassy has begun the process, the passport will be unavailable until the process is complete.

All non UK passport holders must prove UK residency to apply.

For EU nationals, you will need to supply your UK Residency or EU Settlement Scheme (EUSS). You must take the original and a copy to your appointment.

For non EU nationals, you must supply your UK Residence card which must have a minimum period validity of 6 months at the time of submission. You must take the original and a copy to your appointment.

Visas are valid from the date they are issued.

When your documents have been received, we will check that they are correct before contacting you (via the email address provided) to confirm receipt and provide your invoice. If you prefer to send your cheque or postal order with your documents, you can, however we request that no payment is made before we can check that everything is in order.

Payments can be made by PayPal, Bank Transfer, cheque or postal order. Please note that we do not begin to process your request until your payment has been made. All fees are per person.

When you receive the email to confirm when your documents have been received, it will contain your unique reference number. For all queries during your process, you must quote this reference number or we will not be able to provide information. This is to protect your security. We will only email with additional instruction or to confirm the return details for your passport which will contain your visa inside. You must check your visa on receipt & advise immediately if there are any queries.

You will only receive email updates if there are any delays.
