## INFORMATION FOR THE TAJIKISTAN E-VISA SERVICE

The visa is applied electronically, no stamp or visa label will be placed in your passport. When the approval has been granted, we will email it to you, which you must print & carry with you.

The applicant's passport should have at least six months validity & have 2 blank pages on arrival.

Applications should be made no more than 1 month before but no less than 10 business days before expected entry. The e-visa is usually issued within 3 business days but can take longer. We advise that you do not confirm any flight booking until your visa has been issued.

E-Visa fees, once submitted, are non-refundable as they are for the processing of your application regardless of the visa being granted or rejected.

The ETA is valid for 90 days from the date of issue but is limited to 60 days stay from the date of arrival within the validity of the visa. The E-visa can be issued with single or multiple entry but the GBAO permit, if required, is for a single entry only.

You can only hold one ETA at a time.

The GBAO permit is required if you will be entering the Gorno-Badakhshan Autonomous region. Once issued, the permit allows travellers to enter the Gorno-Badakhshan Autonomous region, with the exception of the territory of Sarez Lake.

When your documents have been received, we will check that they are correct before contacting you (via the email address provided) to confirm receipt and provide your invoice. If you prefer to send your cheque or postal order with your documents, you can, however, we request that no payment is made before we can check that everything is in order. Payments can be made by PayPal, Bank Transfer, cheque or postal order. Please note that we do not begin to process your request until your payment has been made. All fees are per person.

When you receive the email to confirm when your documents have been received, it will contain your unique reference number. For all queries during your process, you must quote this reference number or we will not be able to provide information. This is to protect your security. We will only email with additional instruction or to return the approved E-visa. You must check your documents on receipt & advise immediately if there are any queries.

You will only receive email updates if there are any delays.
