Please supply this form, fully completed (typed or by hand), with all documents in the checklist below. Failure to provide any of the documents will result in a delay to your application. All forms must be printed and signed.

If you are sending multiple applications at the same time and the return address is the same for all applicants, you only need to provide one request form per party.

1. CHECKLIST OF DOCUMENTS YOU MUST SEND

ORIGINAL PASSPORT - with a minimum of 6 months validity & 2 blank pages.

APPLICATION FORM - this must be completed at <https://formulario-mre.serpro.gov.br/sci/pages/web/pacomPasesWeb.jsf?aba=-6> -Please ensure all of your visa documents are uploaded with the application. Print and sign the submitted form.

1 UK PASSPORT PHOTO - Must be on a plain white background.

UK RESIDENCY - holders of EU member states must provide a copy of at least 2 of the following documents (no older than 3 months); recent utility bill & recent bank statement whilst nationals of other countries must provide a UK visa/residence permit that is valid for at least 6 months.

POLICE CERTIFICATE – issued by https://www.acro.police.uk/police_certificates.aspx. Certificate is valid for 3 months only. Please contact us if you would like us to apply on your behalf.

ORIGINAL FULL BIRTH CERTIFICATE - if issued outside of the UK, the certificate must be legalised in the country of origin.

INFORMATION FOR THE BRAZIL VISA SERVICE

You can apply no more than 3 months before your planned arrival date. Once the embassy has begun the process, the passport will be unavailable until the process is complete.

This embassy will only process applications for UK nationals or residents.

Processing time in the embassy is usually 5 business days but can take longer. We advise that you do not confirm any flight booking until your visa has been confirmed.

The embassy will issue visa validity according to the approval provided by their Ministry of Labor.

Please ensure that the same photos that are uploaded are provided with your visa application. Using a different photo will result in your application being rejected after the process. Please also ensure that your signature on the application form matches that displayed in your passport.

When your documents have been received, we will check that they are correct before contacting you (via the email address provided) to confirm receipt and provide your invoice. If you prefer to send your cheque or postal order with your documents, you can, however, we request that no payment is made before we can check that everything is in order. Payments can be made by PayPal, Bank Transfer, cheque or postal order. Please note that we do not begin to process your request until your payment has been made. All fees are per person.

When you receive the email to confirm when your documents have been received, it will contain your unique reference number. For all queries during your process, you must quote this reference number or we will not be able to provide information. This is to protect your security. We will only email with additional instruction or to confirm the return details for your passport which will contain your visa inside. You must check your visa on receipt & advise immediately if there are any queries. You will only receive email updates if there are any delays.
