INFORMATION FOR THE CAMBODIA E-VISA SERVICE

This visa is applied electronically, no stamp or visa label will be placed in your passport until you arrive in Cambodia. When the approval has been granted, we will email it to you which you must print & carry with you to Cambodia.

This visa allows the holder to visit Cambodia for a maximum of 30 days.

You can apply no less than 7 days before your intended entry date into Cambodia. You can not apply more than 1 month in advance.

Processing time is approximately 5 business days for standard services or 1 business day for urgent services - but it can take longer if your information needs verification. We advise that you do not confirm any flight booking until your visa has been confirmed.

On arrival, applicants usually need to show their original passport, proof of funds, return flight booking, accommodation booking for their stay and any document required for onward travel, such as a visa, if you are not traveling to your home country from Cambodia. You will also need to show your health insurance certificate.

The e-visa can be used at the following entry points into Cambodia:

Phnom Penh - PNH - Phnom Penh - Phnom Penh
Siem Reap - REP - Siem Reap - Siem Reap
Sihanoukville-KOS-Sihanoukville- Preah Sihanouk
Cham Yeam (Koh Kong Province) (from Thailand)
Poi Pet (Banteay Meanchey Province)(from Thailand)
Bavet (Svay Rieng Province)(from Vietnam)
Tropaeng Kreal Border Post (Stung Treang Province) (from Laos)

When your documents have been received, we will check that they are correct before contacting you (via the email address provided) to confirm receipt and provide your invoice. If you prefer to send your cheque or postal order with your documents, you can, however, we request that no payment is made before we can check that everything is in order.

Payments can be made by PayPal, Bank Transfer, cheque or postal order. Please note that we do not begin to process your request until your payment has been made. All fees are per person.

When you receive the email to confirm when your documents have been received, it will contain your unique reference number. For all queries during your process, you must quote this reference number or we will not be able to provide information. This is to protect your security. We will only email with additional instruction or to confirm the return details for your passport which will contain your visa inside. You must check your documents on receipt & advise immediately if there are any queries.

You will only receive email updates if there are any delays.
