INFORMATION FOR THE PAKISTAN E-VISA SERVICE

The visa is applied electronically, no stamp or visa label will be placed in your passport. When the approval has been granted, we will email it to you, which you must print & carry with you.

The applicant's passport should have at least six months validity & have 2 blank pages on arrival.

Applications should be made no more than 1 month before but no less than 5 business days before expected entry. The e-visa is usually issued within 3 business days but can take longer. We advise that you do not confirm any flight booking until your visa has been issued.

E-Visa fees, once submitted, are non-refundable as they are for the processing of your application regardless of the visa being granted or rejected.

Please note that the documents requested are those published as standard requirements for the visa type. Pakistan authorities may request more documents once they have reviewed your application. We will contact you immediately if any further documents have been requested. In the event that this occurs, processing times are restarted upon submitting the additional documents.

When your documents have been received, we will check that they are correct before contacting you (via the email address provided) to confirm receipt and provide your invoice. If you prefer to send your cheque or postal order with your documents, you can, however, we request that no payment is made before we can check that everything is in order. Payments can be made by PayPal, Bank Transfer, cheque or postal order. Please note that we do not begin to process your request until your payment has been made. All fees are per person.

When you receive the email to confirm when your documents have been received, it will contain your unique reference number. For all queries during your process, you must quote this reference number or we will not be able to provide information. This is to protect your security. We will only email with additional instruction or to return the approved E-visa. You must check your documents on receipt & advise immediately if there are any queries.

You will only receive email updates if there are any delays.
