INFORMATION FOR THE KENYA E-VISA SERVICE

The visa is applied electronically, no stamp or visa label will be placed in your passport. When the approval has been granted, we will email it to you, which you must print & carry with you.

The applicant's passport should have at least six months validity at the time of making application for e-Visas & have 2 blank pages on arrival.

Travellers should have a return ticket or onward journey ticket & may also be requested to show evidence of accommodation during your stay.

Applications should be made no more than 30 days in advance & no less than 5 business days before expected entry into Kenya. The e-visa is usually issued within 3-5 business days but can take longer. We advise that you do not confirm any flight booking until your visa has been issued.

E-Visa fees, once submitted, are non-refundable by Kenyan immigration as they are for the processing of your application regardless of the visa being granted or rejected.

Visas are valid from the date they are issued.

East African visas cover travel into Kenya, Rwanda & Uganda. This visa must be applied to the first country you are entering. The East African visa is valid for 3 months from the date that it is issued with multiple entry.

When your documents have been received, we will check that they are correct before contacting you (via the email address provided) to confirm receipt and provide your invoice. If you prefer to send your cheque or postal order with your documents, you can, however, we request that no payment is made before we can check that everything is in order.

Payments can be made by PayPal, Bank Transfer, cheque or postal order. Please note that we do not begin to process your request until your payment has been made. All fees are per person.

When you receive the email to confirm when your documents have been received, it will contain your unique reference number. For all queries during your process, you must quote this reference number or we will not be able to provide information. This is to protect your security. We will only email with additional instruction or to confirm the return details for your passport which will contain your visa inside. You must check your documents on receipt & advise immediately if there are any queries.

You will only receive email updates if there are any delays.
