INFORMATION FOR THE BAHRAIN ELECTRONIC VISA SERVICE

Required Terms of Service:

- Applicant must be outside the Kingdom of Bahrain when applying for this visa.
- The visa is issued electronically - no visa stamp will be placed in your passport.
- Your entry must not violate the security and national welfare of the Kingdom of Bahrain.

Validity conditions:

- Validity is 90 days. This means the visa must be used within 90 days of approval issue date.
- If the visa expires before entry to the Kingdom of Bahrain, the applicant must apply again, and another fee must be paid.

Entry conditions:

- You must not take up any paid or unpaid employment during your visit to Bahrain.
- You must be able to support yourself (and any dependents) during the visit.
- Passport must be valid for length of time you will be in Bahrain, or the length of the visa, whichever is longer.

If your passport validity is in doubt, you may be denied entry to Bahrain.

- Visitors must have a valid confirmed onward ticket to leave the Kingdom of Bahrain.

Stay conditions:

- The visa can be used for multiple entries and is valid for 3 months from the time of entry.
- The Length of stay allowed is one month in total.

The electronic visa only covers tourist or basic business visits.

You can apply no more than 1 month before your planned arrival date.

Processing time is usually 5 business days but can take longer.

When your documents have been received, we will check that they are correct before contacting you (via the email address provided) to confirm receipt and provide your invoice. If you prefer to send your cheque or postal order with your documents, you can, however, we request that no payment is made before we can check that everything is in order. Payments can be made by PayPal, Bank Transfer, cheque or postal order. Please note that we do not begin to process your request until your payment has been made. All fees are per person.

When you receive the email to confirm when your documents have been received, it will contain your unique reference number. For all queries during your process, you must quote this reference number or we will not be able to provide information. This is to protect your security. We will only email with additional instruction or to confirm the return details for your passport which will contain your visa inside. You must check your documents on receipt & advise immediately if there are any queries.

You will only receive email updates if there are any delays.
